# Windward Orchid Society's

## Criteria for Nomination of Officers, Directors and the Orchidist of the Year

- Eligibility:** Any member in good standing shall be eligible for election to the board of directors.
- Offices:** President, VP President, Treasurer, Recording Secretary, Corresponding Secretary
- Trustees:** 3 positions will be up for nomination.

### Responsibilities:

- President -** Presides at all meetings of the society and board and enforces the by-laws. Supervise all affairs of the organization and shall make an annual report to the organization at the annual banquet. President signs all authorized contracts and performs other duties as assigned by the board. **Term of 1 year.**
- Vice Pres.-** Automatically assumes the duties of the President, if he/she is absent, disabled, resigns or a vacancy occurs. Also assists the President on related duties or requests and takes care of any requests by the board. **Term of 1 year.**
- Treasurer -** Responsible for keeping the books balanced, issuing out checks and depositing them in the organizations account. Gives an monthly report at meetings and keeps an accurate account of all transactions. Submits a financial report at the annual banquet along with an auditors report. Be able to accommodate any members request to inspect the books, with reasonable notification. **Term of 1 year.**
- Secretary-** Keeps true records of all meetings of the organization and is in charge of all documents of the organization. He/she is also the custodian of all supplies and equipment of the organization. Holds the seal of the organization. Handles any documents and amendments with the State and submits files them with the state for as requested. **Term of 1 year.**
- Corresponding Secretary-** In charge of the newsletter and assists the membership committee with their roster for mail outs. Communicates with the other Orchid clubs and assists the Secretary in his/her absence. **Term of 1 year.**
- Trustee-** The business of the organization is managed and controlled by the board, which has authority of exercise the power granted to the organization and By-laws of the State of Hawaii. **Shall serve for a term of 3 years.**
